- B. POST-ACCESSION CLASSIFICATION POLICY: IN ORDER TO KEEP THE LRP BENEFIT AFTER LEAVING THE DEP FOR ACTIVE DUTY, SAILORS MUST CONTINUE THEIR ELIGIBILITY IN ONE OF THE RATINGS LISTED IN PARA. 4A. WHEN RATING CHANGES OCCUR, THE NEW ANNEX TO DD FORM 4 SHALL DOCUMENT THE SAILOR'S CHOICE AND UPDATE THE SAILOR'S ELECTRONIC SERVICE RECORD.
