RMKS//1. THIS MESSAGE SUPERSEDES REF C FOR INDIVIDUALS ENTERING THE DELAYED ENTRY PROGRAM (DEP) ON OR AFTER 1 JAN 05. THOSE ALREADY IN DEP ARE NOT AFFECTED BY THIS MESSAGE.

2. THE AMOUNT OF INCENTIVE THAT MAY BE AWARDED IS DETERMINED BY THE EFFECTIVE AWARD LEVEL MESSAGE. THE AWARD LEVEL MESSAGE IN EFFECT FOR A MEMBER IS DETERMINED BY WHEN THE MEMBER ENTERS THE DEP. IF A MEMBER CHANGES THE PROGRAM OR RATING FOR WHICH THEY ARE ENLISTING OR CHANGES INCENTIVE PROGRAMS WHILE IN THE DEP, THE ORIGINAL EFFECTIVE MESSAGE AT THE TIME OF

ENROLLMENT INTO THE DEP REMAINS APPLICABLE TO THAT MEMBER. DO NOT DISCHARGE AND REENTER A MEMBER FROM THE DEP TO CHANGE AWARD LEVELS. POLICIES AND PROCEDURES CONCERNING ELIGIBILITY, APPLICATION, AND BENEFITS ARE CONTAINED IN REF B.

3. LOAN REPAYMENT PROGRAM (LRP). THE TAR (FTS), AND NON-PRIOR SERVICE BASIC PROGRAMS ARE NOT ELIGIBLE FOR LRP. ALL OTHER RATINGS/PROGRAMS ARE ELIGIBLE FOR LRP (\$65,000 MAXIMUM AMOUNT, APPLIED TO PRINCIPLE BALANCE ONLY, AND ONLY FOR FEDERALLY GUARANTEED LOANS) IN ALL SHIPPING MONTHS SUBJECT TO CONTRACTUAL AGREEMENT. COMBINATIONS OF LRP AND EB ARE NOT ALLOWED EXCEPT FOR THOSE APPLICANTS WHO HAVE AN ASSOCIATE OR BACHELOR'S DEGREE. THOSE PARTICIPATING IN LRP WILL NOT ATTAIN ELIGIBILITY FOR MGIB BENEFITS UNLESS THEY REENLIST AND SERVE AT LEAST 36 ADDITIONAL MONTHS OF ACTIVE DUTY HONORABLY. MEMBERS GUARANTEED LRP CANNOT QUALIFY FOR BOTH LRP AND MGIB DURING THE INITIAL ENLISTMENT. LRP PACKAGES MUST BE RECEIVED BY THE LRP PROGRAM MANAGER PRIOR TO SHIPPING TO RTC. LRP PARTICIPANTS WHO SHIP WITHOUT THE LRP PROGRAM MANAGER HAVING RECEIVED AN ACCURATE AND COMPLETE LRP PACKAGE MAY BE ADMINISTRATIVELY REMOVED FROM THE PROGRAM. LRP PARTICIPANTS ARE REQUIRED TO SIGN A STATEMENT OF UNDERSTANDING (NAVCRUIT 1133/75) THAT STATES, "I UNDERSTAND THAT I AM RESPONSIBLE FOR SUBMITTING ALL REQUIRED DOCUMENTATION AS DEFINED IN THE NAVY ENLISTED RECRUITING MANUAL AND THE LATEST GENERAL ADMINISTRATIVE (GENADMIN) MESSAGE TO THE LRP PROGRAM MANGER AT NAVY RECRUITING HEADQUARTERS IN MILLINGTON TN BEFORE I SHIP (ACCESS). I UNDERSTAND THAT IF I FAIL TO SUBMIT A COMPLETE AND ACCURATE LRP INFORMATION PACKAGE PRIOR TO SHIPPING I MAY BE DROPPED FROM THE LRP PROGRAM AND I WILL CONSEQUENTLY FORFEIT ALL LRP BENEFITS UNDER THE PROGRAM. I UNDERSTAND THAT IF I FAIL TO SUBMIT COMPLETE AND ACCURATE DOCUMENTATION BY MY SHIP DATE AND I AM DROPPED FROM THE LRP PROGRAM, I REMAIN OBLIGATED TO FULFILL MY INITIAL ENLISTMENT CONTRACT."

4. NAVY COLLEGE FUND (NCF). THE NCF PROGRAM PROVIDES AN ADDITIONAL BENEFIT (KICKER) AMOUNT TO THE MONTGOMERY GI BILL (MGIB). SEE REFS (A) AND (B) FOR MORE INFORMATION. COMBINATIONS OF EB AND NCF ARE ALLOWED FOR CERTAIN DESIGNATED RATINGS IDENTIFIED ON THE EFFECTIVE ENLISTMENT BONUS (EB) GENADMIN MESSAGE.

5. NCF FOR PARTICIPANTS WHO ENTER DEP ON OR AFTER 01JAN05 NO LONGER EQUATES TO \$40K OR \$50K IN TOTAL BENEFITS. DOD CHANGES IN NCF POLICY REVISED PREVIOUS PAYMENT AMOUNTS FROM \$40K-\$50K TO A RANGE OF BETWEEN \$150 TO \$950 PER MONTH IN ADDITION TO MGIB PAYMENTS, DEPENDENT UPON PROGRAM AND LENGTH OF OBLIGATION. NCF BENEFIT (KICKER) AMOUNTS ARE PAID WITH THE MGIB PROGRAM BENEFIT UP TO 36 MONTHS OF FULL-TIME BENEFITS.

6. ALL NCF PARTICIPANTS WHO ENTER DEP ON OR AFTER 01JAN05 ARE ELIGIBLE FOR THE \$350 OR \$950 PER MONTH NCF BENEFIT DEPENDING UPON PROGRAM, RATING AND AFQT (ARMED FORCES QUALIFICATION TEST) SCORE, AND ULTIMATE MGIB AND NCF PAYMENT AMOUNTS TO INDIVIDUALS WILL VARY DEPENDENT UPON FULL OR PART-TIME ACADEMIC STATUS, AND LENGTH OF OBLIGATION. THE KICKER REMAINS CONSTANT WHILE THE MGIB MAY CHANGE. FOR EXAMPLE, THE \$350 PER MONTH KICKER BENEFIT EQUATES TO \$12,600 IN ADDITION TO THE MGIB BENEFIT AMOUNT IN EFFECT AT THE TIME THE MEMBER IS PAID (\$36,144 IN FY05 FOR A MAXIMUM BENEFIT OF \$48,744). THE \$950 PER MONTH KICKER BENEFIT EQUATES TO \$34,200 IN ADDITION TO THE MGIB BENEFIT AMOUNT IN EFFECT AT THE TIME THE MEMBER IS PAID (\$36,144 IN FY05 FOR A MAXIMUM BENEFIT OF \$70,344).

7. THE TAR (FTS) AND NON-PRIOR SERVICE BASIC PROGRAMS ARE NOT ELIGIBLE FOR NCF. AN NCF KICKER AMOUNT OF \$950 IS AVAILABLE TO NUCLEAR FIELD (NF) PROGRAM APPLICANTS WHO ARE IN AFQT TEST SCORE CATEGORY I (TSC I) ONLY. ALL OTHER PROGRAMS LISTED BELOW ARE ELIGIBLE FOR THE \$350 KICKER AMOUNT. THE FOLLOWING RATINGS/PROGRAMS ARE ELIGIBLE FOR NCF:
