RMKS/1. EFFECTIVE 1 AUG 01, THIS MESSAGE SUPERSEDES REF B FOR ALL PERSONNEL ENTERING THE DELAYED ENTRY PROGRAM (DEP) AND SCHEDULING TO SHIP 1 OCT 01 OR LATER AND PROVIDES NEW BONUS AMOUNTS FOR FY-02 THROUGH FY-04. FOR PERSONNEL WHO ARE CURRENTLY ENTERING THE DEP, BUT WILL SHIP PRIOR TO 1 OCT 01, AMOUNTS LISTED IN REF B REMAIN IN EFFECT.

- 2. THE EFFECTIVE EB AWARD LEVEL MESSAGE DETERMINES THE AMOUNT OF EB A MEMBER IS ELIGIBLE TO RECEIVE. THE MESSAGE IN EFFECT FOR A MEMBER IS DETERMINED BY WHEN THE MEMBER ENTERS DEP. EB AWARD LEVELS VARY BASED ON SHIP MONTH. IF RECLASSIFICATION OCCURS WHILE IN THE DEP, CLASSIFIERS MUST CAREFULLY NOTE THE AWARD LEVEL FOR THE NEW MONTH TO DETERMINE THE MEMBER'S NEW AWARD LEVEL. SUBSEQUENT EB AWARD LEVEL MESSAGES DO NOT AFFECT A MEMBER'S EFFECTIVE MESSAGE. A MEMBER CHANGES EB PROGRAMS WHILE IN THE DEP, THE ORIGINAL EFFECTIVE MESSAGE AT TIME OF ENROLLMENT INTO THE DEP REMAINS APPLICABLE TO THAT MEMBER. DO NOT DISCHARGE AND REENTER A MEMBER FROM THE DEP TO INCREASE AN AWARD LEVEL. IF A MEMBER CHANGES EB PROGRAMS WHILE AT RTC, AWARD LEVELS ARE DETERMINED VIA THE MESSAGE IN EFFECT ON THE DATE OF RECLASSIFICATION AND BY USING RECLASSIFICATION MONTH AS THE SHIP MONTH. IF A MEMBER CHANGES EB PROGRAMS AFTER RTC, HE IS NOT ELIGIBLE FOR THE EB FOR THE NEW PROGRAM REGARDLESS OF WHETHER OR NOT HE WAS OFFERED EB FOR HIS PREVIOUS PROGRAM. CLASSIFIERS ARE NOT AUTHORIZED TO NEGOTIATE AWARD LEVELS OTHER THAN THOSE DETAILED HEREIN.
- 3. A RETURNING MEMBER WHO IS A NAVY VETERAN (NAVET) OR OTHER SERVICE VETERAN (OSVET), ENLISTING INTO THE NAVY AND WISHING TO BE ELIGIBLE FOR EB, MUST DO SO BY RE-ENTRY AT PAYGRADE E3 OR BELOW AND HAVE NOT PREVIOUSLY RECEIVED AN EB OR SELECTIVE REENLISTMENT BONUS (SRB). NAVETS/OSVETS E4 AND ABOVE SHOULD BE SCREENED FOR SRB ELIGIBILITY.
- 4. EB PAYMENT PROCEDURES. MEMBERS BECOME ELIGIBLE FOR PAYMENT UPON SUCCESSFUL COMPLETION OF ALL REQUIRED PIPELINE TRAINING AND DESIGNATION IN THE SKILL FOR WHICH THE MEMBER ENLISTED. FREQUENTLY

THE MOST APPROPRIATE TIME OF PAYMENT IS AFTER THE MEMBER ARRIVES AT THEIR FIRST PERMANENT DUTY STATION. SERVICING PSDS THAT CAN COMPLETE THE PAYMENT TRANSACTION PRIOR TO THE MEMBERS ARRIVAL AT THE FIRST PERMANENT DUTY STATION ARE ENCOURAGED TO DO SO.

5. EB KICKER/EB FOR COLLEGE CREDIT. MEMBERS ENLISTING IN ANY NAVY RATING WITH COLLEGE CREDIT ARE ELIGIBLE FOR AN EB KICKER. ALL EB GUIDELINES APPLY TO THE EB KICKER INCLUDING A 12 MONTH EXTENSION REQUIREMENT AND PAYMENT UPON COMPLETION OF PIPELINE TRAINING. THE KICKER AMOUNT CAN BE IN ADDITION TO EB, LOAN REPAYMENT PROGRAM, OR NAVY COLLEGE FUND (NCF). THE TOTAL EB AMOUNT SHALL NOT EXCEED \$20,000. COLLEGE CREDITS EARNED WHILE ENROLLED IN THE NAVY CASH PROGRAM DO NOT QUALIFY TOWARDS DETERMINING THE AWARD LEVEL FOR THE EB KICKER. MEMBERS MUST PROVIDE OFFICIAL COLLEGE TRANSCRIPTS PRIOR TO SHIPPING TO RTC. THE FOLLOWING ARE THE AMOUNTS A MEMBER CAN RECEIVE FOR COLLEGE CREDIT:

ASSOCIATES DEGREE = \$4,000 BACHELORS DEGREE = \$8,000

FOR COLLEGE CREDIT EARNED NOT LEADING TO A DEGREE:

- 1 YEAR/900 CLASS ROOM HOURS OF VOCATIONAL TECHNICAL EDUCATION = \$2,000
- 2 YEARS/1800 CLASS ROOM HOURS OF VOCATIONAL TECHNICAL EDUCATION = \$4,000
- 24-47 SEMESTER HOURS (OR EQUIVALENT) OF COLLEGE = \$2,000
- 48-71 SEMESTER HOURS (OR EQUIVALENT) OF COLLEGE = \$3,000
- 72-95 SEMESTER HOURS (OR EQUIVALENT) OF COLLEGE = \$5,000
- 96+ SEMESTER HOURS (OR EQUIVALENT) OF COLLEGE = \$6,000
