RMKS/1. Enlistment Incentives (EI) must attract the highest quality $\frac{1}{2}$

of recruits to fit specific requirements to ensure fleet readiness.

2. Reference (c) provides guidance for determining LRP eligibility. Reference (b) provides guidance for determining bonus eligibility and has been updated with the following exceptions to current policy.

a. Reference (b) paragraph 10.a. (1): EB eligibility determination

is the most recent PRIDE classification transaction.

This could be either the initial classification date (referred to as the delayed entry date (DEP) or reclassification date (change in program, rate or ship date)).

b. Reference (b) paragraph 7.f: EB participants no longer require a 12 month extension for taking an EB.

c. Reference (b) paragraph 9.b.(4): Adds a new bonus type, EB for Ship (EBSHP), to be used as a rating neutral shipping bonus to incentivize shipping during key parts of the year.

EB for Shipping (EBSHP): Active Component (AC) enlistees may be eligible for the EBSHP if they need additional incentive to move their ship date (a minimum of 30 days) up in order for NRC to make monthly accession mission. An enlistee will be awarded a fixed amount. The Annex to DD Form 4 will be updated with the EBSHP and will not be prorated. The EBSHP should be paid upon graduation from RTC. EBSHP can be combined with the EBSR but not with LRP. Due to system limitations, N32 PRIDE operators at NRC Operations will oversee the bonus granting process. The N32 PRIDE section will publish via SEPCOR. Active Duty recruits are eligible for the EBSHP in these ship months in FY18.

(1) EBSHP earned and payable upon graduation of RTC. It is not rating specific. If reclassified at RTC or A/C school, the EBSHP shall be transferred to the new Enlistment Guarantee and still awarded.

- 6. LRP Policy: This message replaces reference (a) for individuals initially classified or reclassified on or after 20 DEC 2017.
- a. Active duty Enlisted Loan Repayment Eligibility: MU-SG.
- b. Post Accession Policy: All Sailors with LRP in their contract, regardless of DEP date or ADSD, are eligible. The Sailor must access to Active Duty and have LRP listed as a guarantee in their current Annex to DD Form 4 (Enlistment Guarantee/NAVCRUIT 1133/52) in order to maintain eligibility. For post-accession inquiries, the LRP Manager is responsible for determining LRP eligibility.
- c. Classifiers will obtain the NRC LRP Manager decision prior to generating the new Annex.
- d. Generally, Sailors that accessed without LRP in their contract are ineligible to receive LRP as a result of reclassification; contact the LRP Manager for specific inquiries.
- 7. EB Repayment policy is governed by reference (a).
- 8. Due to IT limitations EBSHP will be executed in PRIDE MOD II as EBTRG.
