RMKS/1. Enlistment Incentives (EI) must attract the highest quality of recruits to fit specific requirements to ensure Fleet readiness.

This message amends reference (a) and reference (b) for any Future Sailor who contracted with an Enlistment Bonus for Shipping (EBSHP) or with a Loan Repayment Program (LRP) incentive in accordance with reference (a) or reference (b).

Specifically, in the event that a Future Sailor who contracted with EBSHP or LRP and whose ship date is delayed beyond 31 May 2020, at the convenience of the Navy, will remain eligible for these incentives IAW reference (a) and reference (b) regardless of their ship date.

2. The Military Entrance Processing Station Classifiers are required to enter the following statement on the DD FORM 1966/4 of Future Sailors affected by the forced movement:

?Future Sailor original accession date of (list date) moved to (list date) due to COVID-19 shipping adjustment policy. Future Sailor is authorized to maintain eligibility of the EBSHP/LRP authorized per reference (a).?
