NARR/REF A IS ACTIVE COMPONENT ENLISTMENT BONUS (EB) AND LOAN

REPAYMENT PROGRAM (LRP). REF B IS COMNAVCRUITCOMINST 1130.8L,

NAVY RECRUITING MANUAL-ENLISTED.

REF C IS OPNAVINST 1160.9A, THE EB PROGRAM INSTRUCTION.

REF D is National Defense Authorization Act (NDAA) of 2022,

authorizes Enlistment Bonuses through December 31, 2022.

RMKS/1. This messages announces the Enlistment Incentives

(EI) that must attract the highest quality of recruits to fit

specific requirements to ensure Fleet readiness. This message replaces reference (a), for any future Sailor initially classified or reclassified on or after 21 JAN 22.

- 2. The EI Program includes:
 - a. Enlistment Bonus Source Rate (EBSR)
 - b. EB Physical Screening Test (EBPST)
 - c. EB High School (EBHS)
 - d. EB Physical Fitness Assessment (EBPFA)
 - e. EB College Credit (EBCC)
 - f. EB for Shipping (EBSHP)
 - g. Loan Repayment Program (LRP)
- 3. REF D is dependent on congressional appropriations to obligate funds. When funds are not available, the applicant will be required to sign a statement on DD Form 1966 during classification. When legislation restores funding, classifiers can restore incentives based on the effective message at the time of the original classification.
- 4. EB Policy: Reference (e) provides guidance for determining bonus eligibility. The EB maximum limit is \$50,000. If the sum of EBs exceed \$50,000, EBSR will be reduced to maintain total EB at \$50,000.
- a. Contract Policy: While in the Delayed Entry Program (DEP), eligibility determinations are based on the initial date the Service Member enters DEP (see block 5 of DD 4), ship date, and effective message. Eligible bonuses are listed in the new contract and a Statement of Understanding (NAVCRUIT 1133/102) will be completed. Future Sailors will sign an Enlistment Contract (DD 4 and an Annex A to DD 4, Enlistment Guarantees (NAVCRUIT 1133/52)), with all eligible bonuses. Changes in program, rate, and ship date occur often. Classifiers must be vigilant.
 - b. Prior Service Members, either Navy or other services,

re-enlisting onto Active Duty are eligible for bonuses. They must enter Active Duty in pay grade E-4 or below, meet specific bonus eligibility, and not have received a bonus in their first enlistment.

- c. If a Service Member is reclassified while attending training, the EBSR is determined by the current effective message. If EBSHP, EBCC, EBPFA, EBPST, EBHS are listed in the old contract, they are transferred to the new contract.
- d. If a Service Member has a defective contract due to improper or incorrectly determined bonuses, RTC Classifier is authorized to correct the contract prior to affected Sailors graduation from RTC.
- 5. Payments Policy: Sailors can be paid in one or multiple installments based on specific accomplishments of the bonus criteria.
- a. EBPST, EBPFA, EBCC, EBSHP and EBHS are paid upon graduation of RTC.
- EBSR payments will be made by the
 Personnel Support Detachment (PSD) supporting the training pipeline.
- c. Recoupment: Only the unearned portion of the EBSR is eligible for recoupment as outlined in reference (c).
- 6. Enlistment Bonuses:
- a. Active Component Recruits are eligible for the enlistment bonus for source rate (EBSR) in these ship months and fiscal year(s):

- (2) EBSR earned and payable upon graduation from A or C school.
- (3) For Navy aviation rescue swimmer (AIRR) advance technical field (ATF), payment occurs after graduation from Naval Aircrew Candidate School (NACCS), "A" school, Fleet Replacement Squadron (FRS) training, and after arrival at first permanent duty station.
- (4) For special boat (SB) ATF, the payment occurs following graduation from the crewman qualification training (CQT).
- (5) For explosive ordnance disposal (EOD) ATF, payment occurs following EOD *A* school. For Cryptologic Technician Interpretive (CTI) ATF, payment occurs following Language *A* school and first duty station qualification training in the designated language.
- (6) Must have earned the rating NEC and have a security clearance.
 - b. EB for Physical Screening Test (EBPST): Not authorized.
 - c. EB for Physical Fitness Assessment (EBPFA): Not authorized.
 - d. EB for High School (EBHS): Not authorized.
 - e. EB for College Credit (EBCC): Not authorized.
- f. EB for Shipping (EBSHP): Active Component recruits listed below are eligible for EBSHP in these months in FY22 in accordance with (IAW) associated notes. \$4,000 EBSHP is awarded to any newly classified applicant scheduled to ship in January May 2022 or any

rs currently in DEP with a scheduled shipping date of 1 June 2022 or later that rolls in or reclassifies into January - May. Any newly classified applicant scheduled to ship in January - February 2022 or FS scheduled to ship in March - September 2022 that rolls in to ship in January - February 2022 in the below ratings is authorized a \$4,000 EBSHP plus a \$10,000 EBSHP, totaling an EBSHP amount of \$14,000. For example, a newly contracted applicant who enters DEP and is scheduled to ship 1 May 2022 as a CS-5YO is authorized a \$4,000 EBSHP. A FS currently in DEP with a scheduled shipping date of 1 May 2022 as an IT-SG who rolls in to ship in January - February 2022 will be authorized a \$14,000 EBSHP. Any future Sailor in DEP scheduled to ship on or after 1 June 2022 that rolls in to ship during January - May is authorized a \$4,000 EBSHP or a \$14,000 EBSHP if they ship in January - February in a rating authorized an accelerated EBSHP amount.

- (1) Eligibility for EBSHP only exists while the future Sailor is in DEP. EBSHP is earned and payable upon graduation of RTC and may not be recouped due to reclassification or separation.
- (2) Eligibility Policy: NRC classifiers must list the EBSHP separately on the Enlistment Guarantee (NAVCRUIT 1133/52).
- (3) The intent of this EBSHP is to fill shipping gaps in January through May. Newly contracted applicants as well as FS currently scheduled to ship in June September who reclassify or roll into the shipping months of January May are eligible for the bonuses(s) listed above. Recruiting personnel should not advise FS to roll out and back in, in an attempt to qualify for a bonus. FS scheduled to ship January May on the effective date of this message are not eligible for EBSHP. The only exceptions are the following:
- (i) Reclassifications: If the FS reclassifies into one of the specified ratings listed at \$14,000 in the specific shipping month(s) listed, they are eligible.
- (ii) Roll ins: If a FS is scheduled to ship in one of the specified ratings eligible to earn \$14,000 EBSHP but have a shipping date of March or later, they must roll into February or

January to be eligible for the \$14,000.

- 7. LRP Policy: Effective 1 OCT 2021, LRP is not authorized.
