authorizing Commander, Navy Recruiting Command

(CNRC) to modify eligibility for the EB Program, and delegating

responsibilities to CNRC.

RMKS/1. This messages announces the Enlistment Incentives (EI) that must attract the highest quality of recruits to fit specific requirements to ensure Fleet readiness.

This message replaces ref (a) and authorizes enlisted
Reserve Component (RC) shipping bonuses for select RC
ratings that ship during specific periods not otherwise
referred to in ref (f), for any Future Sailor(FS) initially
classified or reclassified on or after 5 August 22 who meet
the conditions of this message.

- 2. The El Program includes:
  - a. Enlistment Bonus Source Rate (EBSR)
  - b. EB High School (EBHS)
  - c. EB College Credit (EBCC)
  - d. EB for Shipping (EBSHP)
  - e. Enlisted Loan Repayment Program (LRP)
- 3. Ref D is dependent on congressional appropriations to obligate funds. When funds are not available, the applicant will

be required to sign a statement on DD Form 1966 during classification. When legislation restores funding, classifiers can restore incentives based on the effective message at the time of the original classification.

- 4. El Policy: Ref (e) provides guidance for determining bonus eligibility. The EB maximum limit is \$50,000. If the sum of EBs exceed \$50,000, EBSR will be reduced to maintain total EB at \$50,000. However, EB and LRP can be combined such that each reach their respective maximum (\$50,000 EB and \$65,000 LRP).
- a. Contract Policy: While in the Delayed Entry Program (DEP), eligibility determinations are based on the initial date the Service Member enters DEP (see block 5 of DD 4), ship date, and effective message. Eligible bonuses are listed in the new contract and a Statement of Understanding (NAVCRUIT 1133/102) will be completed. Future Sailors will sign an Enlistment Contract (DD 4 and an Annex A to DD 4, Enlistment Guarantees (NAVCRUIT 1133/52)), with all eligible bonuses. Changes in program, rate, and ship date occur often. Classifiers must be vigilant.
- b. Prior Service Members, either Navy or other services, re-enlisting onto Active Duty are eligible for bonuses. They must enter Active Duty in pay grade E-4 or below, meet specific bonus eligibility, and not have received a bonus in their first enlistment.
- c. If a Service Member is reclassified while attending training, the EBSR is determined by the current effective message. If EBSHP, EBCC, EBPFA, EBPST, EBHS are listed in the old contract, they are transferred to the new contract.

- 5. Payments Policy: Sailors can be paid in one or multiple installments based on specific accomplishments of the bonus criteria.
- a. EBCC, EBSHP and EBHS are paid upon graduation of RTC.
- b. EBSR payments will be made by the
   Personnel Support Detachment (PSD) supporting the training pipeline.
- c. Recoupment: Only the unearned portion of the EBSR is eligible for recoupment as outlined in ref (c).
- 6. Enlistment Bonuses:
- a. Active Component Recruits are eligible for the enlistment bonus for source rate (EBSR) in these ship months and fiscal year(s):

To remain eligible, they must graduate high school, and receive a DoD Civilian Education code of 12L (High School Graduate with 12 years of education), prior to accession. EBHS is earned and payable upon graduation of RTC and may not be recouped due to reclassification or
- (b) Eligibility Policy: NRC classifiers must list the

EBHS separately on the Enlistment Guarantee (NAVCRUIT 1133/52).

(c) The intent of this EBHS to rebuild DEP and fill vacancies in FY23 T3. Only newly contracted applicants are eligible for the bonuses listed above. Recruiting personnel should not advise FS to roll out and back in, in an attempt to qualify for a bonus.

FS in DEP on the date of this message are not eligible.

- c. EB for College Credit (EBCC): Not authorized.
- d. EB for Shipping (EBSHP):
- (1) Active Component recruits listed below are eligible for EBSHP in these months in FY22 in accordance with (IAW) associated notes. \$10,000 EBSHP is awarded to any newly classified applicant scheduled to ship in August-September 2022 or any FS currently in DEP with a scheduled shipping date of 1 October 2022 or later that rolls in or reclassifies into August-September 2022. Any newly classified applicant scheduled to ship in August-September 2022 or FS scheduled to ship in 1 October or later that rolls in to ship in August-September 2022 in the below ratings is authorized a \$10,000 EBSHP plus up to \$20,000 EBSHP, totaling an EBSHP amount of up to \$30,000. For example, a newly contracted applicant who enters DEP and is scheduled to ship 15 August 2022 as a CS-5YO is authorized a \$10,000 EBSHP. A FS currently in DEP with a scheduled shipping date of 2 October 2022 as an IT-SG who rolls in to ship in August-September 2022 will be authorized a \$25,000 EBSHP. Any FS in DEP scheduled to ship on or after 1 October 2022 that rolls in to ship during August-September 2022 is authorized a \$10,000, \$25,000, or \$30,000 EBSHP if they ship in August-September 2022 in a rating authorized an accelerated EBSHP amount.

- [2] Roll ins: If a FS is scheduled to ship in one of the specified ratings eligible to earn \$10,000/\$25,000/\$30,000 EBSHP but has a shipping date of 1 October or later, they must Roll into August-September 2022 to be eligible for the \$10,000/\$25,000/\$30,000.
- (2) Reserve Component New Accession Training (NAT) recruits listed below are eligible for NAT EBSHP in these months in FY22 IAW associated notes.

For post-accession inquiries, the LRP Manager is responsible for determining LRP eligibility.
