NARR/REF A IS ACTIVE COMPONENT ENLISTMENT BONUS (EB)

AND RESERVE COMPONENT SHIPPING BONUSES. **REF B IS COMNAVCRUITCOMINST 1130.8M**, NAVY RECRUITING MANUAL-ENLISTED. REF C IS OPNAVINST 1160.9A, THE EB PROGRAM INSTRUCTION. REF D is NATIONAL DEFENSE AUTHORIZATION ACT (NDAA) OF 2022, authorizes Enlistment Bonuses through December 31, 2022. REF E IS DOD INSTRUCTION 1304.31, ENLISTED BONUS PROGRAM. REF F IS FY22 SELECTED RESERVE ENLISTED RECRUITING AND RETENTION INCENTIVES, THE EB PROGRAM INSTRUCTION. REF G IS DELEGATION OF AUTHORITY FOR THE EB PROGRAM, authorizing Commander, Navy Recruiting Command (CNRC) to modify eligibility for the EB Program, and delegating responsibilities to CNRC. REF H is Navy Recruiting Command Operations Note that modifies Loan Repayment Program processing policy. RMKS/1. This messages announces the Enlistment Incentives (EI) that must attract the highest quality of recruits to fit specific requirements to ensure Fleet readiness. This message replaces ref (a) and authorizes enlisted Reserve Component (RC) shipping bonuses for select RC ratings that ship during specific periods not otherwise referred to in ref (f), for any Future Sailor(FS) initially classified or reclassified on or after 17 September 22 who meet the conditions of this message. 2. The EI Program includes:

- a. Enlistment Bonus Source Rate (EBSR)
- b. EB High School (EBHS)
- c. EB College Credit (EBCC)
- d. EB for Shipping (EBSHP)
- e. Enlisted Loan Repayment Program (LRP)

3. Ref D is dependent on congressional appropriations to obligate funds. When funds are not available, the applicant will be required to sign a statement on DD Form 1966 during classification. When legislation restores funding, classifiers can restore incentives based on the effective message at the time of the original classification.

4. El Policy: Ref (e) provides guidance for determining bonus eligibility. The EB maximum limit is \$50,000. If the sum of EBs exceed \$50,000, EBSR will be reduced to maintain total EB at \$50,000. However, EB and LRP can be combined such that each reach their respective maximum (\$50,000 EB and \$65,000 LRP).

a. Contract Policy: While in the Delayed Entry Program (DEP), eligibility determinations are based on the initial date the Service Member enters DEP (see block 5 of DD 4), ship date, and effective message. Eligible bonuses are listed in the new contract and a Statement of Understanding (NAVCRUIT 1133/102) will be completed. Future Sailors will sign an Enlistment Contract (DD 4 and an Annex A to DD 4, Enlistment Guarantees (NAVCRUIT 1133/52)), with all eligible bonuses. Changes in program, rate, and ship date occur often. Classifiers must be vigilant.

b. Prior Service Members, either Navy or other services, re-enlisting onto Active Duty are eligible for bonuses. They must enter Active Duty in pay grade E-4 or below, meet specific bonus eligibility, and not have received a bonus in their first enlistment. Additionally, Navy Prior Service Members must have been separated from active duty for at least 12 months prior to shipping to be eligible for bonuses. Prior Service

Members re-enlisting into the

Reserves will use Ref (F) to determine bonus eligibility.

c. If a Service Member is reclassified while attending training, the EBSR is determined by the current effective message. If EBSHP, EBCC, EBPFA, EBPST, EBHS are listed in the old contract, they are transferred to the new contract.

5. Payments Policy: Sailors can be paid in one or multiple installments based on specific accomplishments of the bonus criteria.

a. EBCC, EBSHP and EBHS are paid upon graduation of RTC.

b. EBSR payments will be made by the

Personnel Support Detachment (PSD) supporting the training pipeline.

c. Recoupment: Only the unearned portion of the EBSR is eligible for recoupment as outlined in ref (c).

For post-accession inquiries, the LRP Manager is responsible for determining LRP eligibility.

c. The LRP Manager oversees the application and payment process. REF H modifies application policy by approving applications based on specific conditions, specifically the lack of a signed DD 2475.
