REF J is Office of the Assistant Secretary of Defense for Manpower and Reserve Affairs memorandum authorizing the Navy to increase the maximum enlistment bonuses for selected ratings through 4 June 2028, subject to Congressional reauthorization.

RMKS/1. This message announces the Enlistment Incentives (EI) that must attract the highest quality of recruits to fit specific requirements to ensure Fleet readiness. This message replaces reference (a) and authorizes enlisted Reserve Component (RC) shipping bonuses for select RC ratings that ship during specific periods not otherwise referred to in reference (f), for any Future Sailor (FS) initially classified or reclassified on or after 8 September 2024 who meets the conditions of this message.

2. The EI Program includes:

- a. Enlistment Bonus Source Rate (EBSR)
- b. EB High School (EBHS)
- c. EB College Credit (EBCC)
- d. EB for Shipping (EBSHP)
- e. EB for Armed Forces Qualification Test Score (EBAFQT)
- f. Enlisted Loan Repayment Program (LRP)

3. Reference (d) is dependent on Congressional appropriations to obligate funds. During periods of lapsed appropriations, classifiers may include EB in contracts. However, payments for earned EB will not be made until/unless appropriations are restored to the program.

4. El Policy: Reference (e) provides guidance for determining bonus eligibility.

a. EB Maximum Limit: The EB maximum limit for the Nuclear Field (NUC-NF) is \$75,000. The EB maximum limit for Aviation Rescue

Swimmer (AIRR-ATF), Explosive Ordnance Disposal Technician (EOD-ATF), Hospital Corpsman - Advanced Technical Field (HM-ATF), Information Systems Technician - Submarines (ITS-ATF), Submarine Electronics/Computer Field (SECF-5YO), and Special Warfare Boat Operator (SB-ATF) is \$60,000. For all other rates, the EB maximum limit will be maintained at \$50,000. If the sum of EBs exceeds the maximum limit, the EBSR will be reduced to maintain total EB at the maximum for the specified rating. However, EB and LRP can be combined such that each reach their respective maximum (\$50,000/\$60,000/\$75,000 EB and \$65,000 LRP).

b. Contract Policy: While in the Delayed Entry Program (DEP), eligibility determinations are initially based on the initial date the Service Member enters DEP (see block 5 of DD FORM 4), ship date, and effective message. Eligible bonuses are listed in the new contract and a Statement of Understanding (NAVCRUIT 1133/102) will be completed. Future Sailors will sign an Enlistment Contract (DD 4 and an Annex A to DD 4, Enlistment Guarantees (NAVCRUIT 1133/52)), with all eligible bonuses. For reclassifications that occur while in DEP, the classifier must apply EB that is in effect the day of reclassification, create a new Annex and EBSOU. Changes in program, rate, and ship date occur often.

Classifiers must be vigilant.

c. Prior Service Members, either Navy or other services, reenlisting onto Active Duty are eligible for bonuses. They must enter Active Duty in pay grade E-4 or below, meet specific bonus eligibility, and not have received a bonus in their first enlistment. Additionally, Navy Prior Service Members must have been separated from active duty for at least 12 months prior to shipping to be eligible for bonuses. Prior Service Members re-enlisting into the Reserves will use reference (f) to determine bonus eligibility.

d. If a Service Member is reclassified while attending training, the EBSR is determined by the current effective message. If EBSHP, EBCC, or EBHS are listed in the old contract, they are transferred to the new contract.

e. Classifiers are reminded that in accordance with reference(e), Future Sailors with Tier 3 education credentials are NOT authorized EB.

5. If a Service Member has a defective contract due to improper or incorrectly determined bonuses, a RTC Classifier is authorized to correct the contract prior to affected Sailor's graduation from RTC. Effectively, this invalidates the superseded Annex and a new Annex is placed in the Service Member's official record. For example, a Sailor with a NUC contract originally ships to RTC only with a NUC \$38,000 dollar EBSR. However, when RTC reviews the Sailors contract, RTC discovers that the Sailor was also originally eligible for EBCC, proven by the Sailor's college transcripts. A RTC Classifier will correct the problem with a new contract. If a defective contract is observed after RTC graduation, the Service Member must use the Board for Correction of Naval Records (BCNR) procedures.

6. Payments Policy: Sailors can be paid in one or multiple installments based on specific accomplishments of the bonus criteria.

a. EBCC, EBSHP, EBHS, EBAFQT are paid upon graduation of RTC.

b. EBSR payments will be made by Transaction Support Center

(TSC) Great Lakes.

c. Recoupment: Only the unearned portion of the EBSR is eligible for recoupment as outlined in reference (c).

4. For Special Boat (SB) ATF, the payment occurs following graduation from the Charlie Phase of Special Warfare Combat Crewman (SWCC) Training.

5. For Explosive Ordnance Disposal (EOD) ATF, payment occurs following EOD "A" school. For Navy Diver (ND) ATF, payment occurs following Dive "A" school. For Cryptologic Technician Interpretive (CTI) ATF, payment occurs following Language "A" school and first duty station qualification training in the designated language. b. EB for High School (EBHS): Any School Year (SY) 25 High

School Senior (11S) written and scheduled to ship in June or July 2025 for an Active Component or a Reserve Component TAR rating is authorized EBHS. 11S applicants must be enrolled and attending a Tier 1 tradition high school at the time of the initial contracting date located on the DD Form 4, block 5. To remain eligible, they must graduate high school and receive a DoD Civilian Education code of 12L prior to accession. (a) Active Component recruits who have an accession AFQT Score between 10 and 30 and who attend the Future Sailor Preparatory Course - Academic (FSPC-A) are eligible to receive \$2K in EB for every ten (10) points they improve their AFQT score. EBAFQT is limited to a maximum of \$6K. Future Sailors who are scheduled to ship between May 2024 to December 2024 are authorized EBAFQT according to the following table.

Newly classified or reclassified applicants scheduled to ship in September FY2024 - MarchFY2025 in selected ratings are authorized EBSHP according to the following table. Active Component recruits with a shipping date change due to the needs of the Navy who ship September FY24 - March FY25 are also eligible.

Due to this forced-move, the Service Member remains or becomes entitled to the EBSHP entitlements annotated on the NAVCRUIT 1133/52 Annex and the Enlisted Bonus Statement of Understanding. The MEPS Classifier shall contact the NRC PRIDE Shop to restore the applicable EB entitlements to the future Sailor PRIDE profile.

6. Nuclear Field FSs classified into shipping dates outside of the authorized time period to wait for security clearance adjudication are eligible for the listed EBSHP.

7. FSs currently scheduled to ship on or after October 1, 2024 who roll into September 2024 and FSs who sign a new contract to ship in September 2024 are eligible. This EBSHP may be combined with any rating-based EBSHP for which the FS may be qualified.

Classifiers will obtain the NRC LRP Manager decision prior to generating the new Annex. LRP can be combined with all other EB types. For post-accession inquiries, the LRP Manager is responsible for determining LRP eligibility.

b. Sailors that accessed without LRP in their contract are ineligible to receive LRP as a result of reclassification; contact the LRP Manager for specific inquiries.

c. The LRP Manager oversees the application and payment process. Reference (h) modifies application policy by approving applications based on specific conditions, specifically the lack of a signed DD 2475.

1. Applicants must have a 50 AFQT or above.

2. Approximately 25% of the payment will be withheld for tax purposes.

3. Applicants must submit a DD 2475 for each payment.

4. Applicants will receive an Approval Letter with

instructions.

5. Applicant will receive a W-2 to calculate taxes withheld
