REF D is NATIONAL DEFENSE AUTHORIZATION ACT (NDAA) OF 2026, which authorizes contracts to be entered into with certain Enlistment Bonuses (EB) through December 31, 2026. The availability of bonuses under this policy is subject to congressional reauthorization of Section 331 of Title 37 U.S. Code.

REF E IS DoD INSTRUCTION 1304.31, ENLISTED BONUS PROGRAM.

REF F IS FY25 SELECTED RESERVE ENLISTED RECRUITING AND RETENTION INCENTIVES.

REF G IS DELEGATION OF AUTHORITY FOR THE EB PROGRAM, authorizing Commander, Navy Recruiting Command (CNRC) to modify eligibility for the Enlistment Bonus Program, and delegating responsibilities to CNRC.

REF H is Navy Recruiting Command Operations Note that modifies Loan Repayment Program processing policy.

REF I is Office of the Assistant Secretary of Defense for Manpower and Reserve Affairs memorandum authorizing the Navy to increase the maximum enlistment bonuses for selected ratings through 4 June 2028, subject to Congressional reauthorization.

REF J is Navy Recruiting Command Decision Guidance Memorandum N00-56 Navy Special Operations Recruiting Guidance.

RMKS/1. This message announces the Enlistment Incentives (EI) that must attract the highest quality of recruits to fit specific requirements to ensure Fleet readiness. This message replaces reference (a) for any Future Sailor (FS) initially classified or reclassified after April 26, 2026 who meets the conditions of this message.

2. The EI Program includes:

- a. Enlistment Bonus Source Rate (EBSR)
- b. EB High School (EBHS)
- c. EB for Shipping (EBSHP)
- d. EB for Physical Screening Test (EBPST)
- e. Enlisted Loan Repayment Program (LRP)

3. Reference (d) is dependent on Congressional appropriations to obligate funds. Funding is currently available through September 30, 2026. During periods of lapsed appropriations when recruiting is designated as an exempted activity, classifiers may include EB in contracts with inclusion of the following required language on the DD Form 1966: "Funds are not presently available for payment of enlistment bonuses. The Government's obligation for payment of enlistment bonuses is subject to the enactment of an appropriation from which payment can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Department of the Navy."

4. EI Policy: Reference (e) provides guidance for determining bonus eligibility.

a. EB Maximum Limit: The EB maximum limit for the Nuclear Field (NUC-NF) is \$75,000. The EB maximum limit for Aviation Rescue Swimmer (AIRR-ATF), Explosive Ordnance Disposal Technician (EOD-ATF), Hospital Corpsman - Advanced Technical Field (HM-ATF), Information Systems Technician - Submarines (ITS-ATF), Submarine Electronics/Computer Field (SECF-5YO), and Special Warfare Boat Operator (SB-ATF) is \$60,000. For all other rates, the EB maximum limit will be maintained at \$50,000. If the sum of EBs exceeds the maximum limit, the EBSR will be reduced to maintain total EB at the maximum for the specified rating. However, EB and LRP can be combined such that each reach their respective maximum (\$50,000/\$60,000/\$75,000 EB and \$65,000 LRP).

b. Contract Policy: While in the Delayed Entry Program (DEP), eligibility determinations are initially based on the initial date the Service Member enters DEP (see block 5 of DD FORM 4), ship date, and effective message. Eligible bonuses are listed in the new contract and a Statement of Understanding (NAVCRUIT 1133/102) will be completed. Future Sailors will sign an Enlistment Contract (DD 4 and an Annex A to DD 4, Enlistment Guarantees (NAVCRUIT 1133/52)),

with all eligible bonuses. For reclassifications that occur while in DEP, the classifier must apply EB that is in effect the day of reclassification, create a new Annex and EBSOU. Changes in program, rate, and ship date occur often.

Classifiers must be vigilant.

c. Prior Service Members, either Navy or other services, re-enlisting onto Active Duty are eligible for bonuses. They must enter Active Duty in pay grade E-4 or below, meet specific bonus eligibility, and not have received a bonus in their first enlistment. Additionally, Navy Prior Service Members must have been separated from active duty for at least 12 months prior to shipping to be eligible for bonuses. Prior Service Members re-enlisting into the Reserves will use reference (f) to determine bonus eligibility.

d. If a Service Member is reclassified while attending training, the EBSR is determined by the current effective message. If EBSHP, EBCC, EBHS, or EBAFQT are listed in the old contract, they are transferred to the new contract.

e. Classifiers are reminded that in accordance with reference (e), Future Sailors with Tier 3 education credentials are NOT authorized EB.

5. If a Service Member has a defective contract due to improper or incorrectly determined bonuses, a TSC Classifier with support from assigned classifiers at RTC is authorized to correct the contract prior to affected Sailor's graduation from RTC. Effectively, this invalidates the superseded Annex and a new Annex is placed in the Service Member's official record. For example, a Sailor with a NUC contract originally ships to RTC only with a NUC \$38,000 dollar EBSR. However, when RTC reviews the Sailors contract, RTC discovers that the Sailor was also originally eligible for EBCC, proven by the Sailor's college transcripts. A classifier will correct the problem with a new contract.

If a defective contract is observed after RTC graduation, the

Service Member must use the Board for Correction of Naval Records (BCNR) procedures.

6. Payments Policy: Sailors can be paid in one or multiple installments based on specific accomplishments of the bonus criteria.

a. EBCC, EBSHP, EBHS, EBAFQT are paid upon graduation of RTC.

b. EBSR payments will be made by Transaction Support Center (TSC) Great Lakes.

c. Recoupment: Only the unearned portion of the EBSR is eligible for recoupment as outlined in reference (c).

7. Enlistment Bonuses:

a. Active Component Recruits are eligible for the enlistment bonus for source rate (EBSR) in these ship months and fiscal year(s):

2. EBSR earned and payable upon graduation from A or C school.
3. For Navy aviation rescue swimmer (AIRR) advance technical field (ATF), payment occurs after graduation from Naval Aircrew Candidate School (NACCS), "A" school, Fleet Replacement Squadron (FRS) training, and after arrival at first permanent duty station.
4. For Special Boat (SB) ATF, the payment occurs following graduation from the Charlie Phase of Special Warfare Combat Crewman (SWCC) Training.
5. For Explosive Ordnance Disposal (EOD) ATF, payment occurs following EOD "A" school. For Navy Diver (ND) ATF, payment occurs following Dive "A" school. For Special Warfare Operator (SO) ATF, payment occurs following graduation from SEAL Qualification Training (SQT).
6. Must have earned the rating Navy Enlisted Classification Code (NEC) and have a security clearance.
7. Cryptologic Technician Interpretive (CTI) ATF Sailors must complete cryptologic training and earn one of the following NECs to be eligible for payment: C30A, C31A, C32A, C33A.
8. Missile Technician (MT) Sailors must complete C-School and earn the NEC T48A.
9. HM-ATF Sailors must earn one of the following NECs: L02A, L27A, or L00A.
10. This additional bonus is for Nuclear Field (NF) FSs who volunteer for submarine duty (SUBVOL). FSs must have a completed SUBVOL NAVPERS 1070/613 "Page 13" uploaded and the "Submarine Volunteer" checkbox ticked in their applicant record before the bonus can be added to their Annex. FS SUBVOL status and bonus eligibility

will be verified prior to shipping.

b. EB for High School (EBHS): School Year (SY) 26 High School Seniors written and scheduled to ship from 4 May 2026 to 5 June 2026 in designated Active Component ratings and programs are authorized EBHS according to the table below. Applicants must be enrolled in and attending a traditional or alternative high school program that leads to a DOD Education Code of L (High School Diploma Graduate) or H (Home Study) at the time of the initial contracting date located on the DD Form 4, block 5. To remain eligible, they must graduate high school and receive a DOD Education Code of L or H prior to accession.

2. Eligibility Policy: NRC classifiers must list the EBHS separately on the Enlistment Guarantee (NAVCRUIT 1133/52).

3. The intent of this EBHS is to fill vacancies during the designated shipping period. Recruiting personnel should not advise FS to roll out and back in, in an attempt to qualify for a bonus. FSs currently in DEP are authorized to receive EBHS if they roll in or reclassify into the designated period and are in a designated rating.

4. Future Sailors with an AFQT below 31 are not eligible for EBHS.

c. EB for Physical Screening Test (EBPST):

1. FSs in Navy Special Operations (NSO) ratings (i.e. AIRR-ATF, EOD-ATF, HM-ATF, ND-ATF, SB-ATF, SO-ATF) who meet the elevated Physical Screening Test (PST) standards specified in reference (k) are eligible for the EBPST bonus.

1. Eligibility for EBSHP only exists while the FS is in DEP. The Sailor may not reclassify at RTC. EBSHP is earned and payable upon RTC graduation. The bonus may not be recouped due to post-RTC reclassification or separation.

2. Eligibility Policy: NRC classifiers must list the EBSHP separately on the Enlistment Guarantee (NAVCRUIT 1133/52).

3. The intent of this EBSHP is to fill shipping gaps during the authorized shipping period. Recruiting personnel should not advise FSs to roll out and back in, in an attempt to qualify for a bonus.

4. Future Sailors must have an Armed Forces Qualification Test (AFQT) Score greater than or equal to 31 to be eligible for EBSHP.

5. In the case of a shipping date change due to the needs of the Navy, the following applies: The MEPS Classifier shall annotate the shipping date change on the DD FORM 1966/3 blocks 34b and 34c. The MEPS Classifier shall enter the following entry on the DD FORM 1966/4: 'Future Sailor (Name) scheduled ship date was changed due to the needs of the Navy to align the shipping date with the A School class convening date. Due to this forced move, the Service Member remains or becomes entitled to the EBSHP entitlements annotated on the NAVCRUIT 1133/52 Annex and the Enlisted Bonus Statement of Understanding. The MEPS Classifier shall contact the NRC A&P Shop to restore the applicable EB entitlements to the future Sailor PRIDE profile.

6. Nuclear Field FSs classified into shipping dates outside of the authorized time period to wait for security clearance adjudication are eligible for the listed EBSHP.

7. ADEK-JOG includes the ABE-5YO, ABF-5YO, and ABH-5YO ratings. Future Sailors classified or reclassified into these three ratings may be eligible for the ADEK-JOG bonus if they are placed in an authorized shipping period and meet other listed criteria.

8. FSs currently scheduled to ship after the designated shipping period who roll into an authorized shipping date and FSs who sign a new contract or reclassify into the designated rating and ship in the designated period are eligible.

8. LRP Policy: This message authorizes the Loan Repayment Program for any Future Sailor initially classified or reclassified on or after the effective date of this message. Reference (b) provides guidance for determining LRP eligibility.

a. Active Component Enlisted Loan Repayment Eligibility:

Participants are eligible for LRP if they ship in any month of any FY. Participants in the ratings listed below are eligible.
